NB: Applications submitted before 1 March 2025 will benefit from golf privileges and only be charged the Full membership Excluding Golf entrance fee.


MEMBERSHIP MODEL & FAMILY APPLICATIONS

Applicants Procedure and Conditions for Membership Application

1. Applicants are required to furnish the names and personal signatures of a Proposer and Seconder on the 'declaration' page; together with a letter or e-mail of endorsement from either the Proposer or Seconder advising of the applicants career, family, interests, where you met etc.
2. Each application is on an individual basis. Each individual who would like to join the Club (from aged 12), must complete their own application form and attend a mandatory new member induction.
3. A child aged 12-17 may only be signed up by a Town Member Parent. If you are a minor, your parent or legal guardian must consent to you joining the Club by signing the Application and Declaration and providing the required personal information.
4. Spousal applications' Proposal Declaration to be completed by the main member.
5. There is no joining fee for a Full Member Excluding Golf spouse/partner or child under 17.
6. No candidate shall be eligible for election if such candidate is not a person of appropriate standing having regard to the standards of conduct and esteem expected from members of a club with the standing and repute of the Club. Without limiting the generality of the foregoing, a candidate shall be deemed not to be of appropriate standing if the person (i) is an un-rehabilitated insolvent or (ii) has previously been convicted of any crime, other than a traffic violation, punishable by imprisonment without the option of a fine or (iii) has previously been found guilty by any duly constituted disciplinary forum or body for conduct involving fraud, dishonesty, moral turpitude, sexual harassment, unlawful discrimination or conduct of a like nature or (iv) is, at or during the time of his or her application for membership, the subject of any formal proceedings which could ultimately lead to any of the events contemplated in (i), (ii) or (iii) occurring. Should a candidate thus ineligible be admitted to the Club inadvertently, the Committee may declare his or her election void and shall give him or her immediate notice to that effect, and the Committee shall have the right but not the obligation to return his or her entrance fee or subscription or any part thereof.
7. All new applicants are placed on a waiting list pending their onboarding and subsequent election as a member of the Club.
8. An existing member in good standing, of 2 years or more, may Propose or Second 4 (four) applications per fiscal year (March to February). No members may Propose or Second any candidate who has not been known to him/her personally for at least two years, save that the Committee has the discretion to waive this requirement in special cases.
9. Applications confirmed for election shall be posted on the notice board or online for 14 days. Thereafter, the Main Committee will sign off the ballot and the applicant will be contacted about the outcome of their application.
10. The Committee reserves the right to make external enquiries, which may include contacting Clubs where applicants have been members previously.
11. Each Member of the Club is bound by the Club Rules and all Club Byelaws, which are available on the Club's website under Member Central. Each new member will, when elected as a member, be sent one copy of the Club Rules and is requested to acquaint him or herself fully with the Rules and Byelaws. All Club rules, Byelaws and special dispensations as determined by the Main Committee, are subject to change.
12. By signing this document, you are consenting to The Country Club Johannesburg ('the Club') collecting and storing certain personal information about you (the minimum needed to conduct the administration of this Club). Please be assured that this Club is fully compliant with the Protection of Personal Information Act ("POPIA") regarding how we collect personal information, why we collect it, what it is used for and how it is stored. Please feel free to request to see the Club's POPIA Policy. Your personal information shall not be shared with any third party, whatsoever, save for the GolfRSA approved Handicaps Network Africa handicap service provider ("HNA"), who is fully POPIA compliant.
